Please note the following terms and conditions applicable to this event:

Displays: Event hours: Saturday: 10:00 a.m. to 4:00 p.m. Vender area will be open for set-up on Friday June 5 at noon. Exhibitor agrees that the display will be in place and staffed no later than 10 a.m.

Saturday. All displays must be dismantled and packed by "dark" on Saturday afternoon. Security will be on site but exhibitors are responsible for the safety of their booths and merchandise. Representation of Merchandise: Exhibitor is obligated to honest representation of merchandise.

Sales tax and fees: Exhibitor will be responsible for collecting and paying all applicable sales tax and fees.

Security: Management assumes no responsibility or liability for lost, strayed or stolen items, nor loss by natural or other acts of said items. Liability: Neither The Santa Barbara Carriage Museum, their representatives, agents or employees shall be held accountable or liable and the same are hereby released from accountability or liability for any damage, loss, harm or injury to the person or property of the Exhibitor, or any of his officers, agents, employees or other representatives resulting from theft, fire, water, accidents or other cause; and management will not obtain insurance against such damage, loss, harm or injury. Management will not be held accountable or liable for bodily injury.
